

## Certification

(No Early Procurement Activity under the FY 2021 National Expenditure Program)

 The IATF Memorandum Circular No. 2020-1 requires all Departments/Agencies including GOCCs with budgetary support from the national government to undertake Early Procurement Activities (EPA) for at least 50% of the total value of eligible Procurement Projects included in the proposed budget of the department/agency in the FY 2021 NEP.

The Indicative FY 2021 APP-Non CSE consistent with the FY 2021 NEP, which is the basis for the EPA should be posted on the agency TS page not later than September 30, 2020.

- Philippine Guarantee Corporation (PhilGuarantee) does not have GAA-funded eligible Procurement Projects in the FY 2021 NEP and PhilGuarantee's Indicative FY 2021 APP-Non-CSE was posted on PhilGuarantee TS on September 30, 2020.

Since PhilGuarantee has no GAA-funded eligible Procurement Projects in the FY 2021 NEP, the Certification of Undertaking of Early Procurement for at least 50% of the total value of eligible Procurement Projects included in the proposed budget of the department/agency in the NEP provided for under IATF Memorandum Circular No. 2020-1 could not be submitted and in lieu thereof is submitting this Certification (Re: No Early Procurement Activity under the FY 2021 National Expenditure Program).
- 4.
