In consideration for the sum of **Pesos: Ninety-Seven Thousand One Hundred** (Php97,100.00), inclusive of applicable taxes or such other sums as may be ascertained, FORTMED MEDICAL CLINICS, INC. agrees to the Procurement of Services of a Drug Testing Laboratory to Conduct Drug Testing for PHILGUARANTEE Permanent Personnel in accordance with his/her/its Bid.
