

CONTRACT AGREEMENT

THIS AGREEMENT made the 10th day of December 2021 between **PHILIPPINE GUARANTEE CORPORATION** (hereinafter called "the Entity") of the one part and **FORTMED MEDICAL CLINICS, INC.** with office address at 3rd Floor Crown Center, 158 Jupiter cor. Nicanor Garcia Streets, Bel-Air, Makati City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT OF SERVICES OF A DRUG TESTING LABORATORY TO CONDUCT DRUG TESTING FOR PHILGUARANTEE PERMANENT PERSONNEL** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Pesos: Ninety-Seven Thousand One Hundred (Php97,100.00)**, inclusive of applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Terms of Reference;
 - ii. Request for Quotation;
 - iii. Winning bidder's proposal;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other related documents in relation to bid. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Pesos: Ninety-Seven Thousand One Hundred (Php97,100.00)**, inclusive of applicable taxes or such other sums as may be ascertained, **FORTMED MEDICAL CLINICS, INC.** agrees to the **Procurement of Services of a Drug Testing Laboratory to Conduct Drug Testing for PHILGUARANTEE Permanent Personnel** in accordance with his/her/its Bid.
4. The **PHILIPPINE GUARANTEE CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
