R E S O L U T I O N N O. 2022-072

WHEREAS, the Priority Sectors Guarantee Group – Program Management Department (PSGG-PMD) requested the Bids and Awards Committee (BAC) for the procurement of **Lease of Venue with Food, Accommodation, and Transportation for the 2022 PHILGUARANTEE Business Forum - DAVAO** with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Five Thousand (Php105,000.00)**, inclusive of applicable taxes;

WHEREAS, CFA: 061-2022 in the amount of **Pesos: One Hundred Five Thousand (Php105,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022-Supplemental 4, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, PSGG-PMD in its Memorandum dated April 20, 2022 justified that it resorted in a privately-owned real property and venues for the following reasons:

- a. The nature of the event is a business forum which aims to discuss PHILGUARANTEE's programs such as credit risk, housing and agricultural guarantees. Invited participants/guests are the senior officers, i.e., President/CEO, EVPs, Lending Head from various Financial Institutions (FIs) both private and government who may avail of our programs;
- b. The selected venue is within the Business District of Davao which is accessible and known to be venue of events such as this; and
- c. Per checking with the Davao City Tourism Operations Office, there are no available government facility for Meetings, Incentives, Conferences, and Exhibitions (MICE) venues in Davao City.

WHEREAS, Section V.D.9.c.ii.a and b of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- a. The BAC shall send the RFQ to at least three (3) venues within the vicinity of the selected location. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- b. The venue being offered by the Lessor with the Lowest Calculated Quotation shall then be rated in accordance with the technical specifications prepared pursuant to Appendix B of this Guidelines. Compliance rating with technical specifications may be conducted through ocular inspection, interviews, or other forms of due diligence."

WHEREAS, the Request for Quotation (2nd) was sent on May 6, 2022 to the following suppliers:

1. Acacia Hotel Davao;
2. Dusit Thani Davao;
3. Park Inn By Radisson Davao;
4. Seda Abreeza Hotel; and
5. Waterfront Insular Hotel Davao.

WHEREAS, only Waterfront Insular Hotel Davao submitted its quotation on May 10, 2022; 11:50 A.M. before the deadline of May 10, 2022; 2:00 P.M:

WHEREAS, the PSGG determined that the quotation of **Waterfront Insular Hotel Davao** in the amount of **Pesos: Ninety-Three Thousand Three Hundred (Php93,300.00)**, inclusive of applicable taxes to be the **Single Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated May 10, 2022 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Priority Sectors Guarantee Group - Program Management Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:


- a. The use of **Lease of Real Property and Venue** for the procurement of **Lease of Venue with Food, Accommodation, and Transportation for the 2022 PHILGUARANTEE Business Forum - DAVAO** with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Five Thousand (Php105,000.00)**, inclusive of applicable taxes; and
- b. The award of contract to **Waterfront Insular Hotel Davao** for the procurement of **Lease of Venue with Food, Accommodation, and Transportation for the 2022 PHILGUARANTEE Business Forum - DAVAO** in the amount of **Pesos: Ninety-Three Thousand Three Hundred (Php93,300.00)**, inclusive of all applicable taxes.
