

## CONTRACT AGREEMENT

  - i. Terms of Reference;
  - ii. Request for Quotation;
  - ii. Winning bidder's proposal;
  - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - iv. Other related documents in relation to the bid. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Pesos: Nine Hundred Sixty-Nine Thousand Eight Hundred (Php969,800.00)**, inclusive of applicable taxes or such other sums as may be ascertained, **MICROGENESIS BUSINESS SYSTEMS** agrees to **supply and deliver the services for the procurement of ISO 9001 and 27001 Compliant Unified Management Platform Software License** in accordance with his/her/its Bid.
4. The **PHILIPPINE GUARANTEE CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
