WHEREAS, Philcopy Corporation submitted its quotation on June 24, 2022 at 2:16 P.M. before the deadline of June 27, 2022; 10:00 A.M. in the amount Pesos: Eight Hundred Fifty-Three Thousand Nine Hundred Eighty-Five (Php853,985.00), inclusive of applicable taxes;

WHEREAS, the FGSD recommended the Award of contract to Philcopy Corporation (copy of the memorandum dated June 27, 2022 herein attached as Annex A);
