**RESOLUTION NO. 2022-137**

**WHEREAS**, the Human Resource Organizational Development Department (HRODD) requested the Bids and Awards Committee (BAC) for the **Procurement of Manpower Services for CY 2022** with an Approved Budget for the Contract of **Pesos: Sixty-Seven Million (Php67,000,000.00)**, inclusive of applicable taxes.

**WHEREAS**, CFA:088-2022 in the amount of **Pesos: Sixty-Seven Million (Php67,000,000.00)** was issued by the Budget Management Department for this purpose;

**WHEREAS**, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022-Updated as of June 30, 2022:

**WHEREAS**, the Invitation to Bid was posted on PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE-Jade office bulletin board, for seven (7) calendar days;

**WHEREAS**, the Invitation to Bid was posted on the PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE-Jade office bulletin board, for seven (7) calendar days;

**WHEREAS**, in response to the aforesaid invitation, the representatives from the following service providers attended the pre-bid conference on May 11, 2022;

- 1. Temps and Staffers Inc.;**
- 2. Customer Frontline Solutions; and**
- 3. LSERV Corporation**

**WHEREAS**, only **LSERV Corporation** submitted its bid on June 21, 2022; 10:12 A.M. before the deadline on June 21, 2022; 1:45 P.M.;

**WHEREAS**, during the opening and preliminary examination of bids on June 21, 2022; 2:00 P.M., LSERV Corporation was declared **“PASSED”** on the Technical Components (Eligibility and Technical Requirements);

**WHEREAS**, the Financial Bid of LSERV Corporation was read as follows:

**WHEREAS**, on the same opening of bids, the BAC using the non-discretionary pass or fail criterion, determined **LSERV Corporation** to have failed in its submission of the Price Schedule, since it did not conform with the standard form issued by the Government Procurement and Policy Board (GPPB) for Goods and Services and with the posted bidding documents and was declared disqualified;

**WHEREAS**, pursuant to BAC Resolution No. 2022-124, the BAC has reconsidered the disqualification of LSERV Corporation and declared the submission of **Price Schedule** of LSERV Corporation for the Procurement of Manpower Services as "PASSED", in accordance with Section 5.3 of GPPB Circular No. 04-2020 which provides that:

"The Bidders are highly encouraged to use the templates provided to minimize errors or omissions in the forms submitted. However, failure to use said templates is not a ground for disqualification, provided that the form submitted includes all the mandatory provisions required in the 2016 revised IRR of RA No. 9184 and its associated issuances and as identified in Item 6 of this Circular."

**WHEREAS**, on July 13, 2022, based on the bid evaluation and recommendation made by the TWG, the BAC declared the financial bid of **LSERV Corporation** in the amount of **Pesos: Sixty-Three Million Eight Hundred Eighty-Six Thousand Three Hundred Three and 08/100 (Php63,886,303.08)**, inclusive of all applicable taxes as the **Single Calculated Bid**;

**WHEREAS**, on July 25, 2022, upon recomputation and validation of the financial bid of LSERV Corporation, the TWG determined that there is no correction of bid amount as previously reported, hence, the bid of LSERV Corporation in the amount of **Pesos: Sixty-Three Million Eight Hundred Eighty-Six Thousand Three Hundred Seventeen and 96/100 (Php63,886,317.96)**, inclusive of all applicable taxes is correct;

**WHEREAS**, the TWG also upon verification, validation and ascertainment of the statements made and documents submitted by **LSERV Corporation** the TWG determined that the bid of **LSERV Corporation** is responsive to all the criteria of the post-qualification (legal, technical and financial) and recommended the award of the contract;

**NOW, THEREFORE**, in consideration of the recommendation of the Technical Working Group, the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED** the following:

- a) To declare the bid submission of **LSERV Corporation** as the **Single Calculated and Responsive Bid** for the **Procurement of Manpower Services for CY 2022/PGC-BAC-2022-007G**;
- b) To recommend the approval by the Head of the Procuring Entity (HoPE) of the award of contract for the **Procurement of Manpower Services for CY 2022/PGC-BAC-2022-007G** to **LSERV Corporation** in the amount of **Pesos: Sixty-Three Million Eight Hundred Eighty-Six Thousand Three Hundred Seventeen and 96/100 (Php63,886,317.96)**, inclusive of all applicable taxes.
