- 3. In consideration for the sum of Pesos: Seventy-Nine Thousand Nine Hundred Sixty (Php79,960.00), inclusive of applicable taxes or such other sums as may be ascertained, HOTEL ST. ELLIS agrees to supply venue, food, and accommodation for the Lease of Venue with Food, Accommodation, and Transportation for the 2022 PHILGUARANTEE Business Forum LEGASPI CITY in accordance with his/her/its Bid.
- 4. The **PHILIPPINE GUARANTEE CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
