In consideration for the sum of Pesos: Eighty Thousand Four Hundred Sixty-Five and 44/100 (Php80,465.44), inclusive of applicable taxes or such other sums as may be ascertained, FIRST DATACORP agrees to supply and deliver the subscription of Cloud Video Conferencing Software as a Service in accordance with his/her/its Bid.
  - 4. The PHILIPPINE GUARANTEE CORPORATION agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
