RESOLUTION NO. 2022-208

WHEREAS, the Human Resource and Organizational Development Department (HRODD) requested the Bids and Awards Committee (BAC) for the engagement of a **Service Provider/Consultant as Occupational Health Physician for CY 2022-2023** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Fifty-Seven Thousand Four Hundred (Php257,400.00)**, inclusive of applicable taxes;

WHEREAS, CFA:157-2022 in the amount of **Pesos: Five Hundred Fourteen Thousand Eight Hundred (Php514,800.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022-Updated as of June 30, 2022, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, HRODD in its Memorandum dated November 14, 2022 (copy attached as Annex A), manifested that based on the conducted market research, the proposal of **Dr. Amalia T. Perez** is compliant with the Terms of Reference and most advantageous to the Corporation;

WHEREAS, on the same Memorandum, HRODD has secured the approval of the President and CEO for the engagement of services of **Dr. Amalia T. Perez** as an Occupational Health Physician for CY 2022 to 2023 with the following considerations:

- a. Dr. Perez is a graduate of Medicine and has more than ten (10) years of experience as a doctor and occupational health and safety physician in various organizations; and
- b. Currently, Dr. Perez is the President of the Philippine College of Occupational Medicine, a medical organization; and
- c. The engagement is for six (6) months which may be renewed at the option of the Head of the Procuring Entity.

WHEREAS, Section 53.7 of the Revised IRR of R.A. No. 9184 allows the hiring of an individual to do the work that is highly technical, provided, however, that the term of the individual consultants shall, at the most, be on a six-month basis, renewable at the option of the appointing HoPE, but in no case shall exceed the term of the latter;

WHEREAS, Dr. Amalia T. Perez has submitted a proposal with professional fee in the amount of **Pesos: Forty-Two Thousand Nine Hundred (Php42,900.00)** per month or a total of **Pesos: Two Hundred Fifty-seven Thousand Four Hundred (Php257,400.00)** for six months, inclusive of applicable taxes, together with the following documentary requirements:

- a. BIR Certificate of Registration;
- b. Copy of Professional Identification Card;
- c. PhilGEPS Registration No. 379158; and
- d. Curriculum Vitae.

NOW THEREFORE, in consideration of the recommendation of the Human Resource and Organizational Development Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Highly Technical consultants** for the engagement of a **Service Provider/Consultant as Occupational Health Physician for CY 2022-2023** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Fifty-Seven Thousand Four Hundred (Php257,400.00)**, inclusive of applicable taxes; and
- b. The award of contract to **Dr. Amalia T. Perez** for the engagement of a **Service Provider/Consultant as Occupational Health Physician for CY 2022-2023** in the amount of **Pesos: Two Hundred Fifty-seven Thousand Four Hundred (Php257,400.00)**, inclusive of applicable taxes.


