**RESOLUTION NO. 2022-241**

**WHEREAS**, the Corporate Communications Department (CCD) requested the Bids and Awards Committee (BAC) for the procurement of **One (1) set of Aerial Photo and Video Camera Drone** with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Fifty Thousand (Php150,000.00)**, inclusive of applicable taxes;

**WHEREAS**, pursuant to BAC Resolution 2022-174 (copy attached as Annex B), the Bids and Awards Committee recommended to the Head of the Procuring Entity the award of contract to **Infomax Enterprise** for the procurement of **One (1) set of Aerial Photo and Video Camera Drone** in the amount of **Pesos: One Hundred Forty-Four Thousand Nine Hundred (Php144,900.00)**, inclusive of all applicable taxes;

**WHEREAS**, the CCD in its Memorandum dated December 27, 2022 (copy attached as Annex C), requested the cancellation of the said procurement since the Head of the Procuring Entity has not approved the award of the contract to **Infomax Enterprise**, following Section 41.c.ii Reservation Clause of the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184;

**WHEREAS**, Section 41.c.ii Reservation Clause of the 2016 revised IRR of RA 9184 provides that:

“The HoPE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in the following situations:

For any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the GoP, as follows:

- (i) XXX
- (ii) if the project is no longer necessary as determined by the HoPE; or XXX.”


**NOW THEREFORE**, having considered the foregoing circumstances, the Bids and Awards Committee resolved to request from the Head of the Procuring Entity the following:

- a. Confirmation of the disapproval of the award of contract to **Infomax Enterprise** for the procurement of **One (1) set of Aerial Photo and Video Camera Drone** in the amount of **Pesos: One Hundred Forty-Four Thousand Nine Hundred (Php144,900.00)**, inclusive of all applicable taxes; and

- b. Cancellation of the procurement of **One (1) set of Aerial Photo and Video Camera Drone** with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Fifty Thousand (Php150,000.00)**, inclusive of applicable taxes


