R E S O L U T I O N N O. 2023-035

WHEREAS, the GAD Focal Point System (GFPS) - TWG requested the Bids and Awards Committee (BAC) for the procurement of **Polo Shirts and Gadget Organizers in Celebration of the National Women's Month** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Sixty Thousand (Php260,000.00)** inclusive of all applicable taxes;

WHEREAS, CFA:036-2023 in the amount of **Pesos: Two Hundred Sixty Thousand (Php260,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023 – Supplemental 1, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.”

WHEREAS, the Requests for Quotations (RFQ) were posted and sent on February 15, 2023 to the following suppliers:

1. Angels & Shirts, Garment Inc.;
2. JCManzano Enterprise; and
3. Rulujac Enterprise.

WHEREAS, the following suppliers submitted their quotations before the deadline of March 20, 2023; 10:00 A.M. (PhST);

1. TOPSOL Enterprises received on March 17, 2023, 10:41 A.M.;
2. Berachah Advertising Services received on March 17, 2023, 01:45 P.M.;
3. Knit & Tuck Merchandising received on March 17, 2023, 03:51 P.M.;
4. Avecilla Trading received on March 20, 2023, 09:25 A.M.; and
5. Rulujac Enterprise received on March 20, 2023, 09:25 A.M.

WHEREAS, the GFPS - TWG in its Memorandum dated March 21, 2023 determined that all quotations are not responsive to the requirements of the Corporation, hence requested for the declaration of a failure of bidding and posting of the new Request for Quotation and Terms of Reference;

WHEREAS, Section 35.1 (a) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

“All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation”

NOW THEREFORE, in consideration of the recommendation of the GAD Focal Point System (GFPS) - TWG, the Bids and Awards Committee resolved the following:

- a. To declare a failure of bidding for the procurement of **Polo Shirts and Gadget Organizers in Celebration of the National Women's Month** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Sixty Thousand (Php260,000.00)** inclusive of all applicable taxes:
- a. To post the new Request for Quotation and Terms of Reference for the procurement of **Polo Shirts and Gadget Organizers in Celebration of the National Women's Month** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Sixty Thousand (Php260,000.00)** inclusive of all applicable taxes:
