

TERMS OF REFERENCE

TRAINING AND CONSULTANCY SERVICES FOR THE MAINTENANCE OF THE CERTIFICATION OF THE INTEGRATED MANAGEMENT SYSTEM (IMS) OF PHILIPPINE GUARANTEE CORPORATION

I. Background:

The Philippine Guarantee Corporation (PHILGUARANTEE) is a government owned and controlled corporation resulting from the merger and consolidation of five (5) Philippine Guarantee Programs and Agencies (PGPAs) pursuant Executive Order No. 58, Series of 2018. Being the Principal Agency for State Guarantee Finance of the Philippines, the Corporation have the primary objective to perform its development financing role through the provision of credit guarantees in support of trade and investments, exports, infrastructure, energy, tourism, agricultural business/modernization, housing, MSMEs and other priority sectors of the economy, with the end in view of facilitating and promoting socio-economic and regional development.

In compliance with Executive Order No. 605 institutionalizing the structure, mechanism and standards to implement the Government Quality Management Program (GQMP), all government agencies are directed to adopt a Quality Management System (QMS) certifiable to ISO 9001 in the delivery of its priority government services. Relevant to the ISO 9001:2015 and ISO/IEC 27001:2013 Integrated Management System (IMS) Certification of the Philippine Guarantee Corporation (PHILGUARANTEE), the agency is committed to the continuous implementation and improvement of IMS covering the housing & priority sector guarantee processes and its support processes. Moreover, the organization is also focused on the fulfillment of requirements and development of the information security program of the Information Technology Department and to include a core process in the Agricultural Guarantee Group with the aim to ensure the successful Surveillance Audit to be conducted in the second or third quarter of the year.

Taking into consideration, there is a requirement to engage the services of a Consultant who will provide expert knowledge through training and consultation throughout the project stages from documentation to implementation and audits, and ensure that the PHILGUARANTEE will achieve its objective and benefit from an effective Integrated Management System in the most economic and timely manner.

II. Approved Budget for the Contract

The Approved Budget for the Contract is Eight Hundred Twenty-Five Thousand Pesos (Php 825,000.00) inclusive of applicable taxes.

IV. Terms of Agreement

- 1. The Consultant's services shall be provided to PHILGUARANTEE after the Consultant has received the Notice to Proceed from the PHILGUARANTEE.
- 2. The Consultant's services will be performed at 22nd, 23rd and 24th Floor, 6811 BPI Philam Life Building, Ayala Avenue, 1226, Makati City and should there be changes in the physical office of the Corporation, the same shall be timely communicated to the Consultant. Such change in the physical office of the Corporation shall not, in any way, affect the deliverables of the Consultant.
- Nothing herein shall be construed to create an employee-employer relationship between the Provider/Consultant and PHILGUARANTEE as Client. The Provider/Consultant is not authorized and shall not enter into any obligation on behalf of the PHILGUARANTEE, or commit PHILGUARANTEE in any manner without prior written consent of PHILGUARANTEE.
- 4. The Consultant warrants to:
 - · Conform strictly to all the terms and conditions of this engagement;
 - Work and coordinate with the designated personnel in the performance of the deliverables required by the PHILGUARANTEE;
 - Secure, maintain and update all the necessary registration, licenses and/or permits required under the law at its or his/her own expenses;
 - Comply with all the necessary requirements provided for under the law, rules regulations as well the issuance and directives of regulatory bodies.
- The Consultant shall not use or divulge to anyone, except when such will be beneficial to the PHILGUARANTEE, either during or after the engagement, any of its trade secrets, proprietary information or other proprietary data of any kind whatsoever acquired by reason of this engagement.
- 6. The Consultant shall not assign, transfer, pledge, sub-pledge, or make such other disposition of any of his obligations under the Contract or any part or interest therein.

- 7. The PHILGUARANTEE may, at any time during the duration of this engagement and in case of breach or material default, terminate the contract of services with the Consultant, provided that PHILGUARANTEE will give a 30-day written notice to the Consultant to explain said breach or default, or otherwise cure the same within the conditions set forth in the notice. Failure to do so shall cause the termination of the contract. PHILGUARANTEE shall only be liable to pay the costs of actual services rendered prior to the termination.
- 8. Any reports, studies, and other materials prepared by the Consultant for the PHILGUARANTEE under the contract shall belong solely to and remain property of the PHILGUARANTEE.
- 9. The Consultant shall complete the project in compliance with the Terms of Reference in six (6) months or earlier, from the date of the receipt of the Notice to Proceed. No extension of contract will be given, except due to the following causes: typhoon, earthquake or other natural calamities or other forms of *force majeure*, stoppage or suspension of government work directed by competent authority, civil disorder and other similar and/or analogous causes that will make it impossible for the Consultant to perform its obligations to PHILGUARANTEE. If there is a justifiable reason to extend the contract due to the existence of circumstances mentioned above, PHILGUARANTEE will not be liable for additional costs and the Consultant will not incur any penalty for the late deliverables of the output needed.

The committee shall decide on the best technical specification offer that will be based on the following criteria with a passing rate set at 80% overall score:
