WHEREAS, the GAD Focal Point System (GFPS) - TWG requested the Bids and Awards Committee (BAC) for the procurement of **Polo Shirts and Gadget Organizers in Celebration of the National Women's Month** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Sixty Thousand (Php260,000.00)**, inclusive of applicable taxes;

WHEREAS, CFA:036-2023 in the amount of **Pesos: Two Hundred Sixty Thousand (Php260,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023 - Supplemental 2, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

“ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.”

WHEREAS, the Requests for Quotations (RFQ) were posted and sent on March 28, 2023 to the following service providers:

1. Angels & Shirts, Garment Inc.;
2. JCManzano Enterprise; and
3. Rulujac Enterprise.

WHEREAS, the following suppliers submitted their quotations before the deadline of March 31, 2023; 10:00 A.M. (PhST);

1. SVC Clothing received on March 31, 2023, 09:07 A.M.;
2. Veraliz Marketing received on March 30, 2023, 04:23 P.M.;
3. Berachah Advertising Services received on March 29, 2023, 08:50 A.M.;
4. TOPSOL Enterprises received on March 28, 2023, 04:29 P.M.; and
5. Angels and Shirts Garments, Inc. received on March 26, 2023, 09:22 A.M.;

WHEREAS, the GFPS - TWG determined that the quotation of **Angels and Shirts Garments, Inc.** in the amount of **Pesos: Two Hundred Forty Thousand (Php240,000.00)**, inclusive of applicable taxes to be the **Single Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated March 31, 2023 is attached as Annex "A") and recommended to the BAC its award;

THEREFORE, in consideration of the recommendation of the GAD Focal Point System (GFPS) - TWG, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:
