

INSTRUCTION TO BIDDERS (Fifth Bidding)

- 1. The motor vehicles are being sold as **one (1) lot** and on an "**As Is, Where Is**" basis.
- 2. The Minimum Selling Price of the motor vehicles is indicated in Annex "A" of the Invitation to Bid. Bidders shall accomplish the bid form attached to the Instruction to Bidders.
- 3. A bid shall be accompanied by a bid security equivalent to ten percent (10%) of the bid price in the form of cash, and placed in a sealed envelope addressed to:

- 4. Sealed bids shall be dropped in the bid box located at the lobby of the 23rd Floor of BPI-Philam Building, not later than **1:30 p.m. of April 26, 2023**. The time indicated on the finger-scanning machine at the 23rd Floor Lobby shall be considered the official time. Bids submitted after the **1**:30 p.m. deadline shall not be accepted.
- 5. Bids shall be opened immediately after 1:30 p.m. at the Conference Room, 24th Floor of BPI-Philam Building. Bidder/s or their authorized representative may witness the opening of bids. The bidder's name, the item subject of the bid and the bid price together with the bid security shall be announced and recorded in the Abstract of Bids.
- 6. In case of a tie, the winning bidder will be determined through the rolling of dice, the bidder with the highest number shall be declared as winning bidder. In case of an absent bidder, one of PHILGUARANTEE representatives shall roll the dice in place of the absent bidder.
- 7. The Facilities and General Services Department (FGSD) shall evaluate the bids and the result shall be endorsed to the President and CEO (PCEO) for approval. The PCEO shall approve the award of sale to the winning bidder, within fifteen (15) working days from the date of opening of bids.
- 8. The bidding shall be considered a failure if the offer/s are non-complying as determined by the FGSD. For this purpose, the following are considered non-complying bids:
 - a. Bid submitted is not in the prescribed form;
 - b. No bid security is enclosed;
 - c. Bid security is not in the prescribed form;



- d. Bid security is deficient in amount; or
- e. Bid is below the selling price.

Non-complying bids shall not be announced nor shall these be entered in the abstract of bids. However, the names of those who submitted the non-complying bids shall be entered in the said abstract.

- 9. All non-complying bids shall be returned to the bidders together with the bid security immediately after the FGSD has declared them as such.
- 10. The bid security of the winning bidder shall be considered as partial payment and the balance of the bid shall be paid in the form of cash/manager's cheque within seven (7) working days from receipt of the Notice of Award.
- 11. In case the winning bidder withdraws his/her offer or fails to pay within seven (7) working days from receipt of the Notice of Award, the bid security shall be forfeited in favor of PHILGUARANTEE. The vehicles shall be offered to the next highest bidder and so on until the item is offered to the last bidder. If the last bidder also withdraws his/her offer, PHILGUARANTEE shall declare the bidding a failure.

Bidders who withdrew their bid or failed to pay within seven (7) working days from receipt of the Notice of Award shall not be allowed to participate in the succeeding bidding/s of the motor vehicles.

- 12. Withdrawal of the vehicles shall be made during official working hours only and after full payment of the bid as evidenced by official receipts. Failure on the part of the awardee to claim the vehicle/s within 20 working days from receipt of Deed of Absolute Sale shall cause the cancellation of the award/contract and forfeiture of bid security and other payments.
- 13. All expenses incidental to the withdrawal and registration of the units shall be the responsibility of the winning bidder.
- 14. The Corporation reserves the right to reject any or all offers, or accept such offers as may be considered most advantageous to the Corporation.
