

CONTRACT AGREEMENT

This Contract Agreement (**Contract**) is made and executed on ____ of April 2023 by and between:

PHILIPPINE GUARANTEE CORPORATION (PHILGUARANTEE), with principal office at BPI Philam Life Building, 6811 Ayala Avenue, Makati City, represented by its authorized signatory, MR. IAN A. BRIONES, Senior Vice President of the Corporate Services Group, whose authority is evinced by the Secretary's Certificate attached as Annex A;

- and -

IOM PHILIPPINES, INC. with principal office at 2704-B West Tower, Philippine Stock Exchange Center, Exchange Road, Ortigas Center, Pasig City, herein represented by its duly authorized signatory, MR. TOMAS N. FRANCISCO, President, whose authority is evinced by the Affidavit attached as Annex B;

PHILGUARANTEE invited Bids for the **Procurement of Financial Information System Maintenance and Support Oracle E-Business Suite R-12 Support Services** to be held within sixty (60) calendar days from the issuance of Notice to Proceed;


iOM Philippines, Inc. submitted its quotation in the sum of **Pesos: Nine Hundred Seventy Thousand Two Hundred (Php970,200.00)**, inclusive of applicable taxes based on the requirement specified in the Request for Quotation;


NOW THEREFORE, for and in consideration of the foregoing premises, the Parties have agreed as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Terms of Reference;
 - ii. Winning bidder's quotation;
 - iii. Request for Quotation;
 - iv. Notice of Award; and the Bidder's conforme thereto; and
 - v. Other related documents in relation to the bid. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration of the sum of **Pesos: Nine Hundred Seventy Thousand Two Hundred (Php970,200.00)**, inclusive of applicable taxes, to be paid by PHILGUARANTEE, iOM Philippines, Inc. agrees to **FINANCIAL INFORMATION SYSTEM MAINTENANCE AND SUPPORT ORACLE E-BUSINESS SUITE R-12 SUPPORT SERVICES** in conformity with the Official Bid Documents and this Contract.
4. The **PHILGUARANTEE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. If any term, condition or any part of the provisions of the Official Bid Documents, and this Contract is determined to be invalid, void or unenforceable to any extent, such term,

condition or provision shall be severed from the remaining provisions which shall continue to be valid and enforceable to the fullest extent permitted by law.


