RESOLUTION NO. 2023-063

WHEREAS, the GAD Focal Point System (GFPS) - TWG requested the Bids and Awards Committee (BAC) for the procurement of **Lease of Venue with Food and Accommodation for the conduct of Training-Workshop on Harmonized Gender and Development Guidelines** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Eighty-One Thousand Thirty-Five (Php281,035.00)**, inclusive of applicable taxes;

WHEREAS, CFA:066-2023 in the amount of **Pesos: Two Hundred Eighty-One Thousand Thirty-Five (Php281,035.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023 – Supplemental 2, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, Section V.D.9.b.i of the Consolidated Guidelines for the Alternative Methods of Procurement (Annex H0 of the Implementing Rules and Regulations of Republic Act No. 9184 provides that:

“i. Publicly-owned vis-a-vis privately-owned real property and venue

It is preferred that government agencies lease publicly-owned real property or venue from other government agencies.

If there is an available publicly-owned real property or venue that complies with the requirements of the Procuring Entity, it may enter into a contract of lease with the government-agency owner.

In the event that the Procuring Entity would resort to privately owned real property or venue, the End-User unit shall justify that the same is more efficient and economical to the government”

WHEREAS, the GFPS - TWG determined that the quotation of **Development Academy of the Philippines** (publicly-owned venue) in the amount of **Pesos: Two Hundred Twenty Thousand Four Hundred Five (Php220,405.00)**, inclusive of applicable taxes and other charges to be responsive with the requirements of PHILGUARANTEE (copy of the Memorandum dated April 25, 2023 is attached as Annex "A") and recommended to the BAC its award;


NOW THEREFORE, in consideration of the recommendation of the GAD Focal Point System (GFPS) - TWG, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Lease of Real Property and Venue** for the procurement of **Lease of Venue with Food and Accommodation for the conduct of Training-Workshop on Harmonized Gender and Development Guidelines** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Eighty-One Thousand Thirty-Five (Php281,035.00)**, inclusive of applicable taxes; and
- b. The award of contract to **Development Academy of the Philippines** for the procurement of **Lease of Venue with Food and Accommodation for the conduct of Training-Workshop on Harmonized Gender and Development Guidelines** in the amount of **Pesos: Two Hundred Twenty Thousand Four Hundred Five (Php220,405.00)**, inclusive of all applicable taxes and other charges.


