 - i. Terms of Reference;
 - ii. Request for Quotation;
 - iii. Winning bidder's proposal;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other related documents in relation to the bid. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of Pesos: Seventy-Two Thousand Nine Hundred Sixty (Php72,960.00), inclusive of applicable taxes, to be paid by PHILGUARANTEE, MAX'S KITCHEN, INC. agrees to provide and deliver MEALS FOR GAD ORIENTATION in conformity with the Official Bid Documents and this Contract.
- The PHILGUARANTEE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
