**RESOLUTION NO. 2023-203**

**WHEREAS**, the Human Resource and Organizational Development Department (HRODD) requested the Bids and Awards Committee (BAC) for the **Procurement of a Gender-Responsive Institutional Contract of Service Provider for CY 2023-2024/ PGC-BAC-2023-009G** with an **Approved Budget for the Contract of Pesos: Sixty-Five Million Nine Hundred Nine Thousand One Hundred Seventy and 75/100 (Php65,909,170.75)**, inclusive of overtime pay, administrative fees and applicable taxes.

**WHEREAS**, CFA:108-2023 in the amount of **Pesos: Sixty-Five Million Nine Hundred Nine Thousand One Hundred Seventy and 75/100 (Php65,909,170.75)** was issued by the Budget Management Department for this purpose;

**WHEREAS**, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023-Updated as of June 30, 2023:

**WHEREAS**, the Invitation to Bid and bidding documents were posted on PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE's bulletin board for seven (7) calendar days;

**WHEREAS**, Bid Bulletin Nos. 1, 2, 3 and 4 were posted on PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE's bulletin board on September 5, September 13, September 19 and September 20, 2023, respectively;

**WHEREAS**, in response to the aforesaid invitation, the representatives from LSERV Corp. attended the pre-bid conference on September 22, 2023:

**WHEREAS**, Bid Bulletin No. 5 was posted on PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE's bulletin board on September 27, 2023;

**WHEREAS**, only LSERV Corporation (LSERV) submitted its bid on October 4, 2023, 08:41 A.M. before the deadline on October 4, 2023, 1:15 P.M.;

**WHEREAS**, during the opening and preliminary examination of bids on October 4, 2023, 1:30 P.M., LSERV's bid was declared "**PASSED**" on the Technical Components (Eligibility and Technical Requirements);

**WHEREAS**, the LSERV's Financial Bid was rated "PASSED" and read as follows:

**WHEREAS**, on October 9, 2023 Bid Evaluation, LSERV's bid was calculated as follows:

**WHEREAS**, based on the bid evaluation and recommendation made by the TWG, the BAC agreed on the following:

1. Declaration of LSERV Corp. as the Single Calculated Bid; and
2. To proceed with the post-qualification of LSERV Corporation.

**WHEREAS**, on October 18, 2023 upon verification, validation and ascertainment of the statements made and documents submitted by **LSERV Corporation**, the TWG determined the bid of **LSERV Corporation** responsive to all the criteria of the post-qualification (legal, technical and financial) and recommended the award of the contract;

**NOW, THEREFORE**, in consideration of the recommendation of the Technical Working Group, the Bids and Awards Committee (BAC), hereby **RESOLVES** the following:

- a) To declare the bid submission of **LSERV Corporation** as the **Single Calculated and Responsive Bid** for the **Procurement of a Gender-Responsive Institutional Contract of Service Provider for CY 2023-2024** in the amount of **PESOS: Sixty-Five Million Eight Hundred Seventy Thousand One Hundred Seventy-Nine and 08/100 (Php65,870,179.08)**, inclusive of overtime pay, administrative fees and applicable taxes; and
- b) To recommend approval by the **Head of the Procuring Entity (HoPE)** the award of contract for the **Procurement of a Gender-Responsive Institutional Contract of Service Provider for CY 2023-2024/PGC-BAC-2023-009G** in the amount of **PESOS: Sixty-Five Million Eight Hundred Seventy Thousand One Hundred Seventy-Nine and 08/100 (Php65,870,179.08)**, inclusive of overtime pay, administrative fees and applicable taxes.


