R E S O L U T I O N N O. 2023-042

WHEREAS, the GAD Focal Point System (GFPS) - TWG in its Memorandum dated March 1, 2023, requested the Bids and Awards Committee (BAC) for the procurement of **Meals for Financial Literacy and Wellness Seminar** with an Approved Budget for the Contract (ABC) of **Pesos: Eighty-One Thousand Four Hundred (Php81,400.00)**, inclusive of all applicable taxes;

WHEREAS, CFA:038-2023 in the amount of **Pesos: Eighty-One Thousand Four Hundred (Php81,400.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Requests for Quotations (RFQ) were posted and sent on March 15, 2023 to the following suppliers:

1. ERP Wellness Enterprises;
2. Hizon's Catering Services;
3. Max's Kitchen, Inc. (Shedric Borce); and
4. Roxas Food Ventures, Inc. (The Aristocrat Restaurant).

WHEREAS, no quotation was received on or before the deadline of March 20, 2023; 10:00 A.M.;

WHEREAS, the GFPS - TWG in its Memorandum dated March 28, 2023 requested for the declaration of a failure of bidding;

WHEREAS, Section 35.1 (a) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

“No bids are received”

NOW THEREFORE, in consideration of the recommendation of the GAD Focal Point System (GFPS) - TWG, the Bids and Awards Committee resolved to declare a failure of bidding for the procurement of **Meals for Financial Literacy and Wellness Seminar** with an Approved Budget for the Contract (ABC) of **Pesos: Eighty-One Thousand Four Hundred (Php81,400.00)**, inclusive of all applicable taxes.
