**RESOLUTION NO. 2023-104**

**WHEREAS**, the Recovery Management Department (RMD) requested the Bids and Awards Committee (BAC) for the **Procurement of Security Services for PHILGUARANTEE's Various Acquired Assets** with an **Approved Budget for the Contract of Pesos: Nineteen Million Seven Hundred Ten Thousand (Php19,710,000.00), inclusive of all applicable taxes;**

**WHEREAS**, CFA:076-2023 in the amount of **Pesos: Nineteen Million Seven Hundred Ten Thousand (Php19,710,000.00)** was issued by the Budget Management Department for this purpose;

**WHEREAS**, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023-Supplemental 2:

**WHEREAS**, the Invitation to Bid and bidding documents were posted on PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE's bulletin board, for seven (7) calendar days;

**WHEREAS**, in response to the aforesaid invitation, the representatives from the following prospective bidders attended the pre-bid conference on June 15, 2023:

**WHEREAS**, the Bid Bulletin Nos. 1, 2 and 3 were posted on PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE's bulletin board on June 20, June 22 and June 26, 2023, respectively;

**WHEREAS**, the following bidders submitted their bids before the deadline on June 27, 2023; 9:15 A.M.:

1. Maximum Security and Services Corporation received on June 27, 2023; 7:34 A.M.;
2. Lifeguard Archangels Security Agency Corporation received on June 27, 2023; 8:09 A.M.;
3. MBZ Security Agency Specialist, Inc. received on June 27, 2023; 8:12 A.M.; and
4. Lockheed Federal Security received on June 27, 2023; 9:09 A.M.

**WHEREAS**, during the opening and preliminary examination of bids on June 27, 2023; 9:30 A.M., all bidders were declared “**PASSED**” on the Technical Components (Eligibility and Technical Requirements);

**WHEREAS**, all Financial Bids were rated “**PASSED**” and read as follows:

**WHEREAS**, on July 3, 2023 bid evaluation, bids were calculated as follows:

**WHEREAS**, based on the bid evaluation and recommendation made by the TWG, the BAC agreed on the following:

1. Disqualification of MBZ Security Agency Specialist, Inc. for failing to submit the DOLE membership certificate and the completeness of uniform.;
2. Declaration of Lockheed Federal Security Agency Inc. as the Lowest Calculated Bid; and
3. To proceed with the post-qualification of Lockheed Federal Security Agency Inc.

**WHEREAS**, on July 12, 2023, upon verification, validation and ascertainment of the statements made and documents submitted by **Lockheed Federal Security Agency Inc.** the TWG determined that the bid of **Lockheed Federal Security Agency Inc.** responsive to all the criteria of the post-qualification (legal, technical and financial) and recommended the award of the contract;


**NOW, THEREFORE**, in consideration of the recommendation of the Technical Working Group, the Bids and Awards Committee (BAC), hereby **RESOLVE** the following:

- a) To declare the bid submission of **Lockheed Federal Security Agency Inc.** as the **Lowest Calculated and Responsive Bid** for the **Procurement of Security Services for PHILGUARANTEE’s Various Acquired Assets/PGC-BAC-2023-001G**; and

- b) To recommend approval by the **Head of the Procuring Entity (HoPE)** the award of contract for the **Procurement of Security Services for PHILGUARANTEE's Various Acquired Assets/PGC-BAC-2023-001G** to **Lockheed Federal Security Agency Inc.** in the amount of **PESOS: Eighteen Million Five Hundred Forty-Nine Thousand Seventy-One and 04/100 (Php18,549,071.04)**, inclusive of all applicable taxes.
