WHEREAS, the Information Technology Department (ITD) requested the Bids and Awards Committee (BAC) for the procurement of **IP PBX System** with an Approved Budget for the Contract (ABC) in the amount of **Pesos: Nine Hundred Ninety-Nine Thousand Nine Hundred Ninety (Php999,990.00)**, inclusive of applicable taxes;

WHEREAS, pursuant to BAC Resolution 2023-120, the Head of the Procuring Entity approved the adoption of Small Value Procurement and PHILGUARANTEE's Annual Procurement Plan for FY 2023 – Supplemental 7, viz:

WHEREAS, CFA:114-2023 in the amount of **Pesos: Nine Hundred Ninety-Nine Thousand Nine Hundred Ninety (Php999,990.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Requests for Quotation (RFQ) were posted and sent on September 7, 2023 to the following suppliers:

1. Eastern Telecommunications Philippines, Inc.;
2. SMS Global Technologies Inc.; and
3. Symbolic IT Solution Provider Corp.

WHEREAS, only Eastern Telecommunications Philippines, Inc. submitted its quotation on September 11, 2023, 9:38 A.M. before the deadline of September 11, 2023; 10:00 A.M. (PhST);

WHEREAS, ITD in its Memorandum dated September 12, 2023 determined that the quotation of **Eastern Telecommunications Philippines, Inc.** in the amount of **Pesos: Nine Hundred Ninety-Nine Thousand Nine Hundred (Php999,900.00)**, inclusive of applicable taxes to be the **Single Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Information Technology Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the award of contract to **Eastern Telecommunications Philippines, Inc.** for the procurement of **IP PBX System** in the amount of **Pesos: Nine Hundred Ninety-Nine Thousand Nine Hundred (Php999,900.00)**, inclusive of applicable taxes
