R E S O L U T I O N N O . 2 0 2 3 - 1 7 2

WHEREAS, pursuant to BAC Resolution 2023-118, the Head of the Procuring Entity approved the award of contract to **Red-Com Enterprises** for the procurement of **Portable Hard Drives** being the Lowest Calculated and Responsive Quotation in the amount of **Pesos: Eighty-Four Thousand (Php84,000.00)**, inclusive of applicable taxes;

WHEREAS, the Notice of Award for the procurement of **Portable Hard Drives** was sent to **Red-Com Enterprises** on August 11, 2023;

WHEREAS, Red-Com Enterprises in its email dated August 23, 2023, stated that as a result of their supplier's sales person's mistake on price quotation, and the supplier's management cannot fix the pricing in their favor which will hurt their company financially, hence, Red-Com Enterprises requested for the cancellation of the processing of the purchase order;

WHEREAS, the ITD in its Memorandum dated August 29, 2023, requested the Bids and Awards Committee (BAC) for the cancellation of the abovementioned Notice of Award;

WHEREAS, in the same memorandum, the ITD in its re-evaluation determined that the quotation of **Righconn Enterprises** in the amount of **Pesos: Ninety-Nine Thousand Three Hundred (Php99,300.00)**, inclusive of applicable taxes to be the **Lowest Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE and recommended to the BAC its award;

WHEREAS, Section 40.2 of the 2016 revised IRR of RA 9184 provides that:


"In the case of the failure, refusal or inability of the bidder with LCRB or HRRB to submit the documents required under Section 37.1 of this IRR or to enter into contract and post the required Performance Security, as provided in this Section, the BAC shall disqualify the said bidder, and shall initiate and complete the post-qualification process on the bidder with the second Lowest Calculated Bid/Highest Rated Bid: Provided, however, That in the case of Consulting Services, the second Highest Rated Bid has successfully undergone the negotiation stage in accordance with Section 33.2.5 of this IRR. This procedure shall be repeated until the LCRB or HRRB is determined for award. However, if no bidder passes post-qualification, the BAC shall declare the bidding a failure and conduct a re-bidding with re-advertisement. Should there occur another failure of bidding after the conduct of the contract's re-bidding, the Procuring Entity concerned may enter into a negotiated procurement."


NOW THEREFORE, in consideration of the recommendation of the Information Technology Department, the Bids and Awards Committee resolved to request approval by the Head of the Procuring Entity of the following:

- a. To disqualify **Red-Com Enterprises** from obtaining the award of contract for the procurement of **Portable Hard Drives** in the amount of **Pesos: Eighty-Four Thousand (Php84,000.00)**, inclusive of applicable taxes; and
- b. To award the contract to **Righconn Enterprises** for the procurement of **Portable Hard Drives** in the amount of **Pesos: Ninety-Nine Thousand Three Hundred (Php99,300.00)**, inclusive of applicable taxes.




