  - \*\*\* Pursuant to OGCC Contract Review series of 2023, the bidder must submit together with the signed quotation the original/certified true copy of: [*If a sole proprietorship:*] duly notarized Affidavit or Special Power of Attorney; [*If a partnership, corporation, cooperative:*] duly notarized Secretary's Certificate, Board/Partnership Resolution, or Special Power of Attorney, whichever is applicable; or other similar document showing each representative's authority to execute the contract and should be attached and shall form part of the contract.
